Introduction

ICFOSS would like to initiate collaborative efforts with startups and companies working in FOSS to deliver ICT solutions for organisations under the Government of Kerala and similar ones across India.

Objectives

The collaboration is planned to meet the following objectives:

- Short-term resource augmentation for completing ICFOSS internal projects.
- Utilization of expertise from industry and the community for handling external projects especially government projects.
- Support for FOSS Business solution providers/startups and thereby promoting the overall growth of ecosystem
- Collaborate with experts/startups in research and development of FOSS solutions

Purpose

Work with ICFOSS research team for development and customization of ERPNext solution for various Government departments to meet their ERP requirements.

Scope of work

- Requirements study, requirements management, and documentation through software requirement specification and related project artifacts through structured methodologies
- Define project objectives, deliverables, and timelines right from the start.
- Establish a clear road map for the implementation process, ensuring everyone is on the same page.
- Identify and allocate necessary resources, minimizing delays and bottlenecks.
- Set realistic expectations and manage stakeholders' requirements effectively.
- Streamline communication and collaboration between teams, ensuring a smooth implementation process.
- Customization based on requirements gathered through creating, developing, or extending an existing ERPNext product

- Fine-tuning and maintenance of the codebase; utilize version control and quality assurance when developing applications.
- Testing of products under different conditions.
- Providing training and on-site support to end-clients
- Testing and commissioning of the project as per customer satisfaction
- Providing human resources with adequate competencies and experience for the above.

Essential Requirements

- Strong comprehension of and practical experience with ERP Next customization.
- Proficiency in Frappe Frame Work (technical collaboration with Frappe will be valued as an additional qualification)
- Proficiency in deploying the ERPNext solution on servers located in the cloud and on-site.
- Programming knowledge of ERPNext and Python for data processing.
- Presence in Trivandrum (if not, you shall file an affidavit certifying that the necessary team will be sent to the ICFOSS office within a week of the work order being accepted).

The EOI process

Various departments of the Government of Kerala, has is approached ICFOSS for a customized ERP solution for meeting their ERP requirements. ICFOSS facilitate the entire process by helping departments to finalise technical specifications and customisation of ERPnext,

Following are the steps involved:

1. Call for Expression of Interest among startups incubated/registered with KSUM and registered companies doing FOSS business solution.
2. Submission of EOI (see how to apply)
3. Shortlisted companies will be called for presenting their expertise.
4. Expert panel constituted by ICFOSS, comprising members from Industry, Academy and Government shall evaluate the applications and conduct interview to select the potential partners.
4. Companies with suitable expertise and experience will be empanelled by ICFOSS.
5. Empanelled companies will be requested to submit financial proposals based on high level requirements addressed by ICFOSS.
6. Empanelled company with the best commercial proposal identified by ICFOSS will be requested to go with work agreement as per standard norms applicable to Kerala and proceed with work accordingly.
