## **TENDER DOCUMENT**

ICFOSS (International Centre for Free and Open Source Solutions) invites sealed tenders from eligible and qualified firms/organizations for conducting a **UAV LiDAR Survey** at Technopark Phase I & Phase III Campus, Trivandrum.

#### **Scope of Work**

- Conduct a high-resolution airborne LiDAR survey covering approximately 250 acres.
- Generate precise 3D geospatial data and topographic models suitable for detailed spatial analysis and planning.
- Ensure data quality meets professional surveying standards and geospatial accuracy.

#### Deliverables

The selected agency shall provide the following outputs:

- 1. Raw LiDAR data (LAS/LAZ format)
- 2. **Georeferenced classified point cloud data** with at least the following classes: ground, vegetation, buildings, and other man-made structures
- 3. Digital Terrain Model (DTM) of 10 centimeter resolution
- 4. **Digital Surface Model (DSM)** of 10 centimeter resolution



- 5. **Topographical Map** in the format of shapefiles and DWG files
- 6. **Orthorectified imagery**, if captured
- 7. Final deliverables should be compatible with a common GIS software (QGIS)

### **Technical Qualification Criteria**

- Registered Firm
  - O The bidder must be a registered firm or organization with valid **GST registration in Kerala**.
- Prior execution of Government Projects with Advanced LiDAR Survey Capabilities
  - O Must have successfully completed **at least 3 Government-authorized projects** involving LiDAR-based topographic surveys.
  - O Each project must cover a **minimum of 500 acres** and be valued at **₹2 Lakhs or more**.
  - Each project must include:
    - Data classification
    - DEM/DSM generation
    - Contour creation from LiDAR datasets
  - o Supporting documents: Completion certificates, work orders, or client references.
- Drone Operations & Regulatory Compliance
  - O **The bidder must handle all permissions and approvals** required for drone operations, including application to the regulatory bodies.
  - O The firm must have **DGCA certified drone pilot(s)** with valid credentials.
  - Proof of valid drone pilot license(s) and past drone operations must be submitted.
- **Presence of Operational Office in Kerala** (For Local Facilitation & Coordination)
  - O Bidders must have a **registered and functional office in Kerala**, with local technical manpower. This ensures efficient coordination, site access, data transfer, and communication with local stakeholders.
  - Proof of office address and infrastructure must be submitted (utility bills, registration documents, staff listing).
- Minimum 3 Years of Experience in Similar LiDAR and Geo-Spatial Projects
  - O The firm must have **at least 3 years of experience** in LiDAR survey execution, post-processing, and GIS integration.



- O Experience should be substantiated with **work orders, MoUs, or completion certificates.Project Completion Capability**
- O Bidders must be capable of **completing the project within 20 days** of the work order.
- Preference for Startups
  - **Startups registered in Kerala Startup Mission (KSUM)**, working in the field of LiDAR and geospatial technologies, are strongly encouraged to apply.
  - Preference will be given to eligible startups meeting all technical requirements.

#### Terms & Conditions

#### • Submission of bids

The Tender should be submitted with the following documents. The documents shall include the following:

#### • Earnest Money Deposit (EMD)

The Tender should submit an EMD amount of 1 % (rounded to the nearest rupees) of the total Quoted amount or Rs.1,500/- whichever is maximum. The EMD amount should only be remitted as Bank Drafts in favour of **"ICFOSS"** payable at Thiruvananthapuram and shall be enclosed with the bid.



#### **Forfeiture of EMD**

EMD of a tenderer shall be forfeited, if the tenderer withdraws or amends its tender or impairs or derogates from the tender in any respect within the period of validity of its tender. Further, if the successful tenderer fails to furnish the required performance security within the specified period, its EMD shall be forfeited.

#### **Refund of EMD**

EMD furnished by all unsuccessful tenderer shall be returned to them without any interest whatsoever, at the earliest after expiry of the final tender validity period but not later than 30 days after conclusion of the contract. EMD of the successful tenderer shall be returned, without any interest whatsoever, after receipt of performance security from it as called for in the contract.

#### • Tender Fee

The Tender should submit an non-refundable Tender Fee of Rs.400/- . The Tender Fee should only be remitted as Bank Drafts in name of **"ICFOSS"** payable at Thiruvananthapuram and shall be enclosed with the bid.

- The supplier should avail their service with the same rate for a period of six months, against the purchase order.
- The data offered must be standard, proven product and already available in the market.
- The data offered must follow the required specifications
- Tender Documents shall be available only on the Internet and shall not be available for sales elsewhere.
- No price rise except Govt. levies will be allowed once order has been placed during the validity of the claim.
- Supplier will have to pay penalty on non-delivery after expiry of delivery date @ 1% of quoted price per week subject to maximum of 10%.
- Data should be submitted to the "The Director, ICFOSS, Swatantra, South Pavilion, Sports Hub, Karyavattom, Trivandrum 695 581 Kerala, India".
- If any data or any part thereof is lost or rendered defective during the hand over period, the supplier shall immediately arrange for the supply of the data or part thereof as the case may be.
- **Payment:** The payment shall be made against completion of the entire supplies. The complete payment shall only be made against successful checking of the data supplied. In



case of any defects the L1 bidder shall immediately arrange for the supply of the data or part thereof as the case may be, prior to the payment.

• **Quoted rate:** The quoted rates shall be **inclusive** of all taxes.

**Note:** ICFOSS holds the DSIR certificate which makes ICFOSS eligible for tax exemptions, Seller is responsible for cross checking the category codes and HSN numbers and apply appropriate exemptions

The Taxes may include (excise duty, sales tax, service tax, entry tax etc), duties, levies, freight, handling, loading, unloading, insurance premiums etc complete and shall remain firm throughout the contract period.
